INFORMATION FOR COMPUTER-BASED EXAMINATION (CBE) STUDENTS

Computer-based exams (CBEs) are available for the Introductory and Intermediate levels of the FIA qualification and for the Knowledge level of the ACCA Qualification.

Benefits:

- **Flexibility** – You are not restricted to June and December paper-based exam sessions; CBEs are administered throughout the year.
- **Instant Feedback** – Your result is displayed on the computer screen at the end of the exam.
- **Results** – Your results are uploaded by the licensed centre and will be transferred to your ACCA account within 72 hours.

Students, who are interested in sitting these examinations, may register for the programme at any time throughout the year. **First - Submit your ACCA/FIA Registration documents to ICAJ. Then – Upon receipt of confirmation, contact the Overseas Examination Commission to register for the Computer Based-Examinations.**
